



# Information on personal data in the Norwegian Arthroplasty Register

You have received this letter from the Norwegian Arthroplasty Register (NAR) because you have had or soon will undergo joint replacement surgery. Every time a person has a joint replacement operation in Norway, the details are recorded in the NAR. You are not obliged to have this information in the NAR and you can object at any time to the processing of your data. It will have no effect on the treatment you receive if you choose not to have your data in the Register. You will find information on how you can object at the end of this letter. If you do not object to be registered in the registry you don't need to do anything.

#### The purpose of the Register

The Norwegian Arthroplasty Register (NAR) is a national medical quality register. The purpose of the Register is to develop new knowledge that can help to prevent illnesses and injuries that lead to hip replacements, as well as improving and quality assuring treatment methods and patient care. The main aim is thus to improve the quality of treatment of people with various types of joint replacements. The Register also forms an important basis for research. Emphasis is placed on patients' quality of life and satisfaction. A further goal is to provide information and advice to surgeons and public agencies on the best treatments.

Haukeland University Hospital, Helse Bergen, is responsible for processing data for the Register. Day-to-day operations are performed by the Register itself, which is part of the Orthopaedic Clinic of Haukeland University Hospital. Helse Bergen is responsible for ensuring that your data are processed according to Norwegian law, the European General Data Protection Regulation and the Norwegian Health Register Act. NAR is a national medical quality register and all the information about you are handled according to <a href="Lov om helseregistre og behandling av helseopplysninger">Lov om helseregistre og behandling av helseopplysninger</a> (helseregisterloven) Forskrift om medisinske kvalitetsregistre and Personvernforordningen artikkel 6 nr. 1 bokstav e and artikkel 9 nr. 2 bokstav j The NAR is based on op-out according to <a href="helseregisterloven">helseregisterloven</a> § 10 and <a href="mailto:forskrift">forskrift</a> om medisinske kvalitetsregistre § 3-2.

## The Register will contain the following data about you:

- General information: name, date of birth and ID number, address and gender. The National Population Register will be consulted to ensure that your personal data are correct.
- Health information: type of joint replacement, date of of surgery, information on the implant and surgical method, etc.
- Patient-reported information on quality of life, function and pain following a joint replacement (PROM).

The data are collected from an electronic form completed by the surgeon immediately after your operation; the surgeon then sends the form to the NAR. In addition, before and at 1, 6 and 10 years after your operation you will be asked to complete a questionnaire about your quality of life, pain and satisfaction with the result of your operation. This is entirely voluntary. For some health issues, we may wish to contact you for further questions.

### Linkage with information from other sources

In connection with research projects or to ensure that the data in the NAR are complete and correct, it may be appropriate to obtain data related to joint replacements from other public registers. Each time another

Relevant registers for accessing such data are the Norwegian Prescription Database, the Norwegian Cardiovascular Disease Registry, the Medical Birth Registry of Norway, the Norwegian Cancer Registry, the Cause of Death Registry, the Norwegian Information System for the Nursing and Care Sector (IPLOS), The Norwegian Hip Fracture Register, The Norwegian Knee Ligament Register, the Norwegian Paediatric Hip Register and the Norwegian Patient Registry (this contains data on all patients admitted to hospital or treated at outpatient clinics or by specialist doctors).

Personal data will not be used for research, unless the study has been approved by the Regional Committees for Medical and Health Research Ethics, the privacy officer of the institution responsible for the research or the Norwegian Data Protection Authority.

Disclosure of data from the NAR will only be permitted when this is in accordance with the aim of the Register. Names, dates of birth and ID numbers are replaced by a code when data are disclosed. In this way, the data are de-identified and cannot be traced back to you. All information collected is treated confidentially, and all those whose work involves data in the Register are bound by confidentiality obligations regarding any information that may be available to them. Helse Bergen, the data controller, will ensure that your privacy rights are protected at all times. Data about you will be deleted when storing data is no longer within the purpose of the registry.

### Right of access, modification and deletion of data

You have the right of access to information held about you. If you believe that the information about you is incorrect, you can ask for it to be corrected. You also have the right to request deletion of your personal data from the Register.
